CLARIFICATION: GENERAL AUTHORISATION IN TERMS OF SECTION 39 OF THE NATIONAL WATER ACT, (ACT 36 OF 1998): ALTERING THE BED, BANKS, COURSE OR CHARACTERISTICS OF A WATERCOURSE

CAPE LIME: FARM WELVERDIEND 511, REMAINING EXTENT, RD VANRHYNSDORP

Your letter, dated 28 October 2014 and the Amended Basic Assessment Report, dated October 2014 (DEA&DP Ref: 16/3/1/1/F3/16/3020/13) and subsequently site visit conducted, has reference.

General Authorizations (GA) were promulgated in Government Notice No.1198 dated 18 December 2009, in terms of Section 39 of the National Water Act, 1998 (Act 36 of 1998). The GA authorizes all or any category of persons to use water in terms of Section 39(1) of the Act, read together with Section 21, in respect of the conditions attached to the GA.

In terms of the information provided to the Department by Total Impact Assessments (Pty) Ltd on behalf of the Water User, Cape Lime (Pty) Ltd, the water use will fall within the limits set in above mentioned GA, provided that all conditions specified in the GA are complied with. (Attached please find a copy of the relevant GA applicable to this water use.)

The Department has confirmed that the water uses in terms of Sections 21 (c) and (i) on the proposed footprint of the mining activity and the proposed works as described in the Amended Basic Assessment Report, dated October 2014, is covered under the General Authorization in terms of Section 39 of the National Water Act. However, other water uses may trigger the need for a water use license and must be dealt with when the need arises.
